The process of gifting a vehicle If you are signing over the title of your vehicle to a new owner, you will need to provide the recipient with: The vehicle title signed by the transferor and the new owner. Plus, the signatures of any lien attached to the vehicle, if applicable.

Gifted or Donated Vehicles The motor vehicle sales tax applies to the fair market value of the vehicle at the time of the gift or donation. For more information, see the Driver and Vehicle Services of the Department of Public Safety website. Note: A business cannot use their direct pay authorization to buy motor vehicles exempt from tax.

### Gifted or Donated Vehicles | Minnesota Department of Revenue

California sales tax generally applies to the sale of vehicles, vessels, and aircraft in this state from a registered dealer. Use tax applies to the sale of vehicles, vessels, and aircraft purchased from non-dealers (for example, private parties) or from outside California for use in this state.

This page covers the most important aspects of California's sales tax with respects to vehicle purchases. For vehicles that are being rented or leased, see see taxation of leases and rentals . California collects a 7.5% state sales tax rate on the purchase of all vehicles, of which 1.25% is allocated to county governments.

### Sales tax on cars and vehicles in California

A sales tax-satisfied stamp is required with the appropriate exemption number. Gift: If the vehicle is a gift, the sales price must be noted as "GIFT". If the information appears to be changed or altered, additional documentation may be required by the Motor Vehicle Commission.

### **NJ MVC | Vehicles Exempt From Sales Tax**

Gifts. The transfer of a motor vehicle between specifically identified individuals is not charged sales tax if the transfer is a gift for no monetary or other consideration, or other expectation of consideration. The specific individuals are: spouses, parents and children, and grandparents and grandchildren.

### **DVS Home - Motor Vehicle Sales Tax**

The new owner's social security number, taxpayer identification number (TIN), or federal employer identification number (EIN) is required. Use this form when sales tax was not collected at the time of purchase or when the vehicle was received as a gift. If the donor/seller is not required to complete Section 6, the new owner must have a copy of the bill of sale signed by the seller.

### **Form DTF-802:5/15: Statement of Transaction - Sale or Gift ...**

If the vehicle was a gift or was purchased from a family member, use the Statement of Transaction {Sales Tax Form} (pdf) (at NY State Department of Tax and Finance) (DTF-802) to receive a sales tax exemption. If you paid out-of-state sales tax, show the out-of-state dealer bill of sale.

### **New York DMV | Sales tax information**

You may be exempt from paying sales tax on a vehicle transferred to you as a gift from another person. The person transferring the vehicle must have met the tax laws of the state they registered it. You must pay a \$25 fee and the title and registration fees. The person gifting the vehicle must complete a sales tax exemption form (MVU-24).

Colorado Vehicle Gift Bill of Sale is an instrument required to establish the proof of ownership of a motor vehicle upon receiving it as a gift. However, it is necessary that no consideration of any type involving money or goods be involved. Notarization of the seller's signature is necessary for the legal standing of this document.

The dealer will collect motor vehicle sales tax from the purchaser when a motor vehicle is purchased from a dealer in Texas, if the motor vehicle has a gross weight of 11,000 pounds or less. The tax is a debt of the purchaser until paid to the dealer. The dealer will remit the tax to the county tax assessor-collector.

### **Motor Vehicle - Sales and Use Tax**

An exemption from the sales or use tax for a motor vehicle transferred as a gift is provided for in the Massachusetts regulations and statutes. In order to be exempt from the sales and use tax, you must meet the requirements of the law and complete the affidavit above. You must fill in all blanks and print or type your entries, except at the end of the affidavit where your signatures are required.

### **California City and County Sales and Use Tax Rates ...**

The tax is imposed on motor vehicles purchased (or acquired by gift or transfer) from another individual or private party. (Sales of motor vehicles from registered Illinois dealers are taxed under the Retailers' Occupation Tax Act.)

**Private Party Vehicle Use Tax - Sales Taxes**

Motor Vehicles and Vessels Received as Gifts No sales and use tax is due on a vehicle or vessel received as a gift. A Motor Vehicle or Vessel Gift Declaration AU-463 is required, signed by the donor. The donor cannot receive any consideration (cash, property, service, assumption of debt, etc.) in return.

**Motor Vehicles and Vessels Received as Gifts**

Yes, if there was any payment, barter, exchange, or service for a vehicle. This type of transaction does not qualify as a gift, and you must pay Sales Tax on the fair market value of the vehicle. If there was a lien on the vehicle, then Sales Tax is due on the loan amount assumed.

**NJ Division of Taxation - Motor Vehicle Casual Sales ...**

You may be penalized for fraudulent entries. Call DOR at (608) 266-2776 with any sales tax exemption questions. WisDOT collects sales tax due on a vehicle purchase on behalf of DOR. Any taxes paid are submitted to DOR. If sales tax is paid in error, tax refund requests must be made directly to DOR.
